TERMS AND CONDITIONS

Payment & Contact: The contact person on the contract is responsible for the exact tent location, signs the rental contract, and submits payment. **Payment is due on or before the time of installation;** unless payment terms are set up in advance. Please make certain the contact person or designee is available upon installation.

Tent Site: **If the tent site is being reserved or rented from another agency, it is your responsibility** to notify them of the scheduled day, we will set up AND take down the tent. If there is a locked gate to the site, please make certain this gate will be open prior to our arrival. If there is a conflict gaining access to the tent site, or the crew has to wait for you or your designee, you may be charged an additional fee of \$25.00 per hour per person in the crew. Or a prorated amount if less than an hour.

If the location or surface type changes, please let us know immediately to avoid any additional charges you may occur for additional labor, rescheduling, and/or equipment rental to complete your set-up.

Set up & take down: **The tent area shall be clear by 8:00 am on the scheduled day to set up, and all items cleared by 8:00 am on the scheduled day to take down.** If you have other rental companies with any items under the tent, please allow for their time to clear the tent prior to booking the take down with us. We must be the first on site to set up, and the last on site to take down. In the event our crew has to clear items from under the tent; we will not be responsible for any damage or lost items. You will be charged for their additional time and labor.

All underground utilities must be clearly marked prior to our arrival to set up the tent.

Frame tent rentals with water barrels are excluded. Notify your city for any required permits, and to mark all water & sewer lines. If you are in Texas, call Texas Excavation System at 1-800-344-8377. Advise them we will dig deeper than 16". They will notify the local utilities excluding water and sewer, to have the lines marked. If outside of Texas, please contact your local agencies. Normally notice of two (2) business days is required.

This is mandatory to insure the safety of all parties involved. If the lines are not marked, we will not set up the tent, until the lines have been properly located and marked. This delay could cause additional charges to you. Even if you have no underground lines, there may be existing water, sewer, phone, electricity, or gas lines there. If you set up annually in a rented area, please do not rely on your memory or the memory of our installers for the whereabouts of the lines. Aquila & Priscilla Tentmakers Inc will NOT be responsible for any cut or damaged utility lines, nor for the loss of utility service. Nor will any representatives of Aquila & Priscilla Tentmakers Inc. Any cost arising from damage or loss of utilities will strictly be the responsibility of the Lessee. In the event an employee of Aquila & Priscilla Tentmakers Inc should be injured or if death should occur due to the Lessee not properly having the lines located and marked, or if the Lessee falsifies the location of the lines causing injury or death to an employee of Aquila & Priscilla Tentmakers Inc., the Lessee and/or the company the Lessee is representing, will be responsible for any cost for treatment, loss of wages, or any other services performed for such employee.

Customers are expressly **forbidden** from modifying or removing poles, stakes, chains, etc., or moving the tent to another location without our permission. In the event you move any of the above and cause damage to the tent or equipment, you will be responsible for all repair charges. If you call us to make a trip to your location and correct your mistake, you will be charged a \$35.00 trip charge, as well as mileage and after hour rates, which will be determined at that time.
